Senator Vincent L. Leibell is in his seventh term as a New York State Senator. His district includes Putnam County and parts of Dutchess and Westchester Counties. Prior to his election to the Senate, Senator Leibell served in the Assembly for six terms. He is the current chair of the Senate Standing Committee on Veterans, Homeland Security and Military Affairs. As Chairman, Senator Leibell's responsibilities include the oversight and approval of legislation relating to all aspects of homeland security, veterans issues and military and naval affairs. A Navy veteran, Senator Leibell has served on active duty and in the Naval Reserve, and is currently the Deputy Commander for Security Affairs for New York State Naval Forces, holding the rank of Rear Admiral. Before becoming a Member of the New York State Assembly, Senator Leibell was an Associate Counsel to the New York State Senate Banking Committee. Previously, the Senator served as the County Attorney of Putnam County and as an Assistant District Attorney in Westchester County. While working as an Assistant District Attorney, Senator Leibell was assigned to both the Rackets and Appeals Bureaus. Senator Leibell holds a Bachelor's Degree in Economics and a Law Degree from St. John's University, and a Master's Degree in Public Administration from New York University. Senator Leibell and his wife Helen reside in the Town Patterson. They are the proud parents of three children.
